In exercise of the powers conferred by sub-section (1) of section 3 of the Kerala Forest Produce (Fixation of Selling Price) Act, 1978 (29 of 1978) read with sub-section (4) of the said section, the Government of Kerala having decided it necessary so to do and after having consulted the Expert Committee constituted under section 4 of the said Act and having considered their recommendations hereby refix the selling price of Eucalyptus for



the remaining period of the financial year 2021-2022 with effect from the date of this notification and make the following amendments to the notification issued as G.O.(Ms.) No.11/2021/F&WLD dated the 9th July, 2021 and published as S.R.O. No.515/2021 in the Kerala Gazette Extraordinary No.2048 dated 12<sup>th</sup> July, 2021,namely:-

### AMENDMENT

In the Schedule to the said notification, in the entry in column (5) under the heading "Price for standing timber at site" for the figures "7300" against Sl.No.3, the figures and word "4600, 5100 and 5400" shall be substituted.

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

In exercise of the powers conferred by sub-section (1) of section 3 of the Kerala Forest Produce (Fixation of Selling Price) Act, 1978 (29 of 1978), the Government had issued notification under G.O.(Ms.)No.11/2021/F&WLD dated 9th July, 2021 and published as S.R.O. No.515/2021 in the Kerala Gazette Extraordinary No.2048 dated 12th July, 2021, fixing the selling price of the forest produce for the financial year 2021-22. It has come to the notice of the Government that the prices of various species of Eucalyptus range from Rs.4000/stacked tonne to Rs.6500/stacked tonne. The Expert Committee constituted under section 4 of the said Act have recommended the Government for fixing the selling prices of three species of Eucalyptus namely Eucalyptus clones and hybrid as Rs.4,600/stacked tonne, Eucalyptus grandis as Rs.5,100/stacked tonne, Eucalyptus pellitta as Rs.5,400/stacked tonne. Hence the Government have decided to refix the price for standing timber at site of three species of Eucalyptus.

The notification is intended to achieve the above object.
