- 1. The Tender Forms can be collected from Sub unit office Arippa on payment of cost of Tender documents during the office hours. - 3. Cost of Tender Form is not refundable.
- 4. Intending Tenderers should enclose along with the Tender a certificate regarding their permanent address with their signature attested by the concerned Village Officer or attested copies of identity cards issued by the Election Commission or driving license or passport or Aadhar Card.
