- 1. Managing Director explained the background and concept of tourism at wagamon, present facilities and requirement. A Detailed Project Report (DPR) has to be prepared by the agency to be selected. Keeping in mind the architectural, gardening sensibilities, forest law restrictions and adding tourist amenities, nature education facilities, stay facilities, activities for tourists etc.
- 2. GPS readings of the boundary of the area and presentation photos will be shared with prospective bidders and KML files will be uploaded in site.
- 3. Regarding acceptability of incomplete projects as company experience, it was clarified that DPR should have been approved and at least one phase should be completed. Fully, completed projects will have more marks.
- 4. Regarding ratio of technical: financial marks, it was clarified 50:50 ratio will prevail.
- 5. Payment for implementation will be given after all works implementation only. DPR agency is for overall supervision. There will be a separate implementing agency as Project Management consultant where needed. However, a separate agreement can be there for implementing stage so that partial payments can be made.
- 6. Point of contact should be available in Kottayam at least during DPR preparation period- on call.
- 7. Payment of EMD etc will be in favour of 'Managing Director, Kerala Forest Development Corporation'.
