3. The lowest rate quoted, if reasonable, will be accepted and the successful quotationer should supply the materials immediately on receipt of the supply order. They should supply the material at KFDC Gavi Division.
4. The rate quoted should be inclusive of all taxes, duties, cesses and transport charges, otherwise it should be shown separately.
